

Rules - LASIK Strike Out Contest

One entry per person.

No purchase necessary to win. The four Selected Participants for the Contest will each receive four free tickets to the Friday, June 14, 2019 or Friday, August 2, 2019 Norfolk Tides game.

Each Contest entrant must be (i) a legal resident of the United States, (ii) 25 years of age or older at the time of entry into the Contest, and (iii) not an Excluded Entrant, as provided herein.

Excluded Entrants: (A) Employees of Virginia Eye Consultants or the Norfolk Tides and its affiliates and related entities. The immediate family and household members (spouse, parent, grandparent, child, sibling, and any step relatives) of each of the foregoing, are expressly excluded as Qualified Entrants and are not eligible to participate in the Contest or win any Contest Prize; and (B) the following individuals are also excluded from participation in the Contest: (i) any current or former professional baseball or softball player; (ii) any current or former semi-professional baseball or softball player; (iii) any current or former collegiate or Olympic baseball or softball player who played at such level within the last six years; and (iv) any current or former baseball or softball coach who has coached at the collegiate level or higher within the last six years. Each individual that satisfies each of the foregoing requirements and is not an Excluded Entrant is hereinafter referred to as a Qualified Entrant.

The Contest entries begin on Friday, May 3, 2019 and ends on Monday, June 3, 2019.

The Contests will be held during the Friday, June 14, 2019 and Friday, August 2, 2019 Norfolk Tides games at Harbor Park in Norfolk, Virginia.

To enter the Contest, the Qualified Entrant must, in accordance with the guidelines and time frames outlined in these Official Rules, complete and submit an online contest entry form located at www.virginiaeyeconsultants.com/strikeout

Four Qualified Submissions will be randomly selected by Virginia Eye Consultants and the Norfolk Tides and the Selected Participants will be notified by phone and/or email by noon on Thursday, June 6, 2019. The selected contestants will need to confirm that they can participate in the contest by Friday, June 7, 2019 at noon. If a selected contestant does not confirm by that time, an alternate contestant will be selected and notified.

At the Contest, Selected Participants will be required to sign a waiver for the Norfolk Tides. They will then be provided with an official International League baseball. Only the issued ball will be permitted for use during the Contest. The Selected Participants will then be invited onto the field during a pre-determined inning break to participate in the Contest.

Format of the Contest: At each of the two games, two selected Participants will each have three chances to throw a strike into the strike zone of the Strike Out contest board.

Winner: The Selected Participant with the most balls to go through the strike zone will be deemed the Winner. Selected Participants will be expressly prohibited from taking a practice throw (doing so shall eliminate the Selected Contestant from the Contest). Any determinations relating to the Contest, including, without limitation, the success of the throws, will be made at the reasonable discretion of the Norfolk Tides.

In the event that there is a tie, the winner will be decided by a coin toss.

The Grand Prize Winner must claim his/her Contest Grand Prize by contacting Virginia Eye Consultants at 757-390-4202 within fifteen calendar days to schedule a consultation.

In the event that a Grand Prize Winner does not contact Virginia Eye Consultants within fifteen calendar days, the Grand Prize Winner will forfeit any and all interest in the Contest Grand Prize. In such a case, neither Virginia Eye Consultants nor the Norfolk Tides will have any further obligation to the Grand Prize Winner and the Grand Prize Winner will have no further claim against Virginia Eye Consultants or the Norfolk Tides.

Contest Prize is non-refundable and non-redeemable for cash. Contest prize is transferable if Prize Winner is not a suitable candidate for LASIK. Virginia Eye Consultants, at its sole discretion, reserves the right to substitute a comparable prize, of the same or greater value, for the named Contest Grand Prize.

If no entrant qualifies as a Qualified Entrant for the Contest then no Contest will be held and no Contest Prize will be awarded.
